GUIDELINES FOR THE PAYMENT OF FEE

> The first sibling will get discount of 20% and second sibling will get discount of 30% on tuition fee.

> If the fee is not deposited by the stipulated date, a fine of **SR. 2/-** per day will be charged for a maximum of **30 days** after which the school authorities reserve rights to take an appropriate action on non-payment of school fee.

> The fee for the academic year is divided into 4 installments; any student joining or leaving any time during the session will have to pay minimum three installments inclusive of the full annual charges.

> Transport facility is optional and provided to those students who are within a distance of 30 km from the school.
